Report 2006-07 by Cornelia Weber

1. Database

The database presently has 2,566 (06/07: 2,245) records encompassing museums and collections from 61 (06/07: 56) countries or territories: Africa 11, America 475, Asia 274, Australasia 326, Europe 1480 (see: <u>http://publicus.culture.hu-berlin.de/collections/</u>)

Thanks to the great work of Luisa Fernanda Rico Mansard and her colleagues it was possible to collect the data of university museums and collections in México (see also UMAC in México: <u>http://publicus.culture.hu-berlin.de/umac/regional_mexico.html</u>).

The National University of Colombia, Bogotá, provided a survey of its museums and collections.

2. Research project

Since 2004, Cornelia Weber has been working on a project to catalogue all German universities' collections and to compile extensive data on the holdings and the history of these collections (<u>http://publicus.culture.hu-berlin.de/sammlungen/index.php</u>), funded by the German Research Foundation (DFG). Until 30.07.08 759 existing university museums and collections have been registered.

This project can be seen as a first model version to collect information about university collections and museums for an online database.

Aims 2008-09

To collect further information about university museums and collections worldwide and expand the database in the number of records it contains.

The electronic version also enables UMAC to provide information in other formats including multimedia elements such as videos of workshop sessions, roundtables and panel discussion. It will reduce expenses significantly.

Report 2007-08 by Peter Tirrell

We have made great progress in our planning since forming a Working Group at our 2005 Conference in Uppsala, Sweden. At our 2007 Conference in Vienna, we had an open session with Conference participants. The aim and progress of the Strategic Plan were discussed. The Strategic Plan and the planning process also were discussed and critiqued by the Board. The Board approved the Plan. Several important decisions or "BENCHMARKs" were approved. The Board established the WG for Advocacy and expressed the need to develop a "tool kit" that can be used to show the value of university museums and collections. The Board decided that it would appoint Chairs of WGs and make all other special appointments to the Board. These actions have been added to webpage "Function/Aim, 2008 Goals & Objectives, and History" that is on the planning http://publicus.culture.hustrategic section of our website: berlin.de/umac/strategicplan/.

Since our Conference, Members of the WG, Board Members, and the Chair of UMAC have proposed several new strategies. These included:

1. Simplify and streamline the Strategic Plan to make it easier for Members to understand.

2. Review the Goals, Strategies and Actions in terns of priority and importance.

3. Pursue Publication of our Proceedings in the format of an electronic journal.

4. Create a "Help" section on the webpage that provides Technical Information, Helpful articles, Peer consultation and a Help Blog.

5. Create an evaluation tool to assess the state of a museum (e.g., level of performance).

6. Prepare an Operational Plan to accompany the Strategic Plan.

- 7. Prepare a budget for 2008-2010.
- 8. Prepare Guidelines for speakers at Conferences.

9. Create a Tool Kit

All the proposed strategies were reviewed by the WG and incorporated into the Plan as strategies except 5 – this suggestion was deemed too difficult and inappropriate for UMAC although programs of evaluation from several countries were listed on the website. Members of the WG with the assistance of Board Members did strategies 1, 2, 3, 4, 6 and 8. Strategies 6 and 9 are in planning.

Planning Process

The WG maintained contact and participated in discussion via email (over 150 messages). The WG Chair (Tirrell) had live videoconferences with the UMAC Chair (Weber) to discuss the strategic planning process, revisions to the Plan and new strategies (15 videoconferences). Draft materials were distributed to the WG and the Board for their review and comment.

Comments from the Chair: Peter Tirrell

In 2007 - 2008, we made a great deal of progress towards our goals through our strategies and actions. We are the only ICOM Committee that has prepared a strategic plan. As we continue to revise and refine our Plan, it becomes clearer to see what we

want to do and how we will do it. We have prioritized several of our goals and strategies and we have improved our services. The planning process also becomes easier as we discard ideas that are not important or that we cannot do.
