Report 2006-07 by Cornelia Weber

1. Database

The database presently has 2,245 (04/05: 2,197) records encompassing museums and collections from 56 (04/05: 50) countries or territories: Africa 11, America 382, Asia 265, Australasia 326, Europe 1298 (please see: <http://publicus.culture.hu-berlin.de/collections/>)

2. Research project

Since 2004, Cornelia Weber has been working on a project to catalogue all German universities' collections and to compile extensive data on the holdings and the history of these collections (<http://publicus.culture.hu-berlin.de/sammlungen/index.php>), funded by the German Research Foundation (DFG). Until 13.07.07 759 existing museums and collections have been registered.

This project can be seen as a first model version to collect information about university collections and museums for an online database.

Staffing Working Group

Function/Aim

This group has in the past compiled data from Australia and Europe, but the immediate utility of such data was overshadowed by the labour for further compilation.

Report 2006-07 by Ing-Marie Munktell

At the last meeting in Mexico the chair made a short summary on the history and aims of the group: The WG Staffing was formed in Barcelona in 2001. The aims were to identify the special occupational group "university and collection staff" and to list their needs (or minimum needs for professionalisation) and finally to raise their profile. The background was our experience that universities often neglect the existence of collections and the need for special staffing. We saw the need for standards of professionalism among museum and collection staff. Inspiration came from the two Australian publications "Cinderella Collections" and "Transforming Cinderella Collections".

The group also made a minor investigation of UMAC members using a questionnaire concerning staffing. The result showed the wide gap between small "one man" collections and huge professional museums. After that we discussed using the ICTOP (International Committee for Training of Personnel) as a recommendation to our colleagues for development plans in our museums.

In Mexico city there was an interesting discussion on salaries and lack of job descriptions. Linda W Bahm promised to send an overview of salaries and job descriptions.

Panu Nykänen asked why we are not in better contact with our Baltic and Russian colleagues.

It was decided to work on the latter proposal.

The discussions in Mexico City then focused on establishing a space on the web site for the exchange of information concerning exchange programs, best practice and financing possibilities. The platform is now linked to our UMAC page (see: <http://publicus.culture.hu-berlin.de/umac/staffing.html>)

Uppsala University Museum/Museum Gustavianum and Helsinki University Museum/ Arppeanum have already started a pilot exchange. Staff from Uppsala went to Helsinki and now also staff from Helsinki has been to Uppsala. The experiences are very positive from both sides and we are now planning for a project together connecting also our colleagues in Tartu (Estonia) and St Petersburg (Russia).

Recognition Working Group

Report 2006-07

At the last conference in 2006 in Mexico it was realised that the factors that UMAC needs to address for greater recognition are organised on a regional, rather than global scale. It was therefore decided encourage members to set up regional groups with the aim of achieving regional recognition, or to stimulate existing regional groups to collaborate with UMAC in achieving our goals.

Luisa Fernanda Rico Mansard, Dirección General de Divulgación de la Ciencia, Autonomous University of Mexico, started a regional initiative (“working table”) in Mexico, in cooperation with Bertha Teresa Abraham Jalil, Autonomous University of the State of Mexico, and Lourdes Monges Santo, Historical Collections of the Popular Art Museum.

At the first meeting on 22 November 2006 the group laid down the following main working lines:

1. Create a working group entirely dedicated to museums in universities.
 2. Integrate a complete database of the university collections and museums.
 3. Form a complete web list with people who works in university museums.
 4. Detect the main interest of university museums to improve their services.
 5. Provide members with specialized information about university museums.
 6. Create spaces in which these topics can be expressed.
 7. Connect the national museum group with the International Committee.
- Since the first meeting in November 2006 the regional group has met three times.

Publications Working Group

Function/Aim

This group was established in 2003. It co-ordinates the publication of publications in electronic and print form deemed to be in the interest of UMAC and the university museum's community. It is responsible for oversight of the selection, editing and printing the double blind refereed Conference Proceedings.

Report 2006-07 by Peter Stanbury & Marta Lourenço

1. Mexico Conference Proceedings

Immediately following the 2006 conference in Mexico City, discussions were held between Stephen de Clercq and Peter Stanbury (representing the UMAC Publication Group) and Rafael Sámano, Gabriela Fong, Graciela de la Torre, Lourdes Monges, Ma. Josefina Garduño Colin, Silvia Singer representing the UMAC's Mexican hosts. The latter generously suggested publishing a selection of the UMAC conference papers as a museological reference book sponsored by Anuies and UNAM under the working title of *New Roads for University Museums*. The UMAC working group accepted the proposal in principle and suggested a comprehensive working list of authors.

The project was developed in Mexico and by May 2007 the Publications working group were invited to agree to the proposed table of contents and to co-ordinate the gathering of the papers in English, with final copy subject to a very short deadline. The gathering of the Spanish contributions, the final editing and the publication would be undertaken in Mexico under the oversight of Ana Cue. After further negotiations the deadline was extended to August: still short in the view of the Working Group, but necessary for funding reasons within Mexico. The arrangements have been confirmed in a letter to all contributors from Graciela de la Torre.

2. Conference guidelines

During the year discussions were held about the guidelines for UMAC conferences. A shortened and simplified version was drafted to assist the 2008 hosts, but requires final ratification by the UMAC Board.

3. Future Aims

Past experience has shown that the development of guidelines for the publication of the proceedings are complicated by the local conditions and circumstances at the place at which the conference takes place, the availability of a suitable publication, funding and editors. Up to the present time UMAC has managed to publish a selection of its annual conference presentations, but this has been a matter of luck, the occasional grant, generosity of hosts and journals and the dedication of volunteers. UMAC may not be so fortunate in the future unless it requires those hosting conferences to negotiate the publication of selected conference presentations in a manner appropriate to the Board.

4. Thank you

The two retiring Co-Chairs thank the Working Group members, referees, Journal Editors and Conference Hosts for their assistance in the work of the Group and their interest in promoting the cause of university museums throughout the world.

Report 2006-07 by Peter Tirrell

1. Discussion of 2006 Survey Analysis at 2006 Conference, Mexico City

Peter Stanbury, in place of Peter Tirrell, Chair (who was unable to participate), held a general discussion with Members at the 2006 Conference in Mexico City. There were many important goals and objectives that were indicated by the survey and analysis performed in 2006. These goals and objectives were discussed and prioritized. The priorities serve as a guide for our planning and strategies for several years. The three most important goals and the three most important objectives by highest rank were (available on UMAC website):

2. Preparation of the Strategic Plan**2a Resources**

The following resources were reviewed: notes from the Conferences at Uppsala, Seoul, and Mexico City, the UMAC website, the ICOM website, and correspondence by the Board and the Members over the past three years (approximately 100 emails and documents) and notes taken in conversations with Board Members and Conference participants. New information was gained from the Task Force regarding the priority goals and objectives. Information also was received from several Members who responded to a request for input (6/20/2007) regarding the following questions: What new services should UMAC provide? How can UMAC seek new members and retain previous members? How can UMAC promote partnerships with other groups and organizations? The Chair also used information found in strategic plans created by other museums, museum organizations, and published information.

2b. Communications

Eight (8) videoconferences were held between the Chair and UMAC Chair to discuss the strategic planning process. The discussion focused on needs and concerns of UMAC including financial stability, succession planning, WGs, advocacy, and progress of the planning process. The Chair also communicated by email with the Task Force, Board Members, and Members.

2c. Revision of UMAC's Mission, Vision, and Priority Goals

The mission, vision and priority goals were revised with the assistance of input from the Task Force, Board Members, Members and the Chair of UMAC. A new goal was added regarding leadership, management, and strategic planning. Goals are:

- Identify and Promote the Values of University Museums and Collections
- Provide Services That Inform, Communicate, Encourage Participation, and Share Resources
- Share Best Practices
- Seek New Members and Retain Previous Members
- Promote and Develop Strategic Partnerships, International Cooperation and Exchanges
- Promote Research and Generate New Ideas
- Solicit Information
- Create a Sound and Sustainable Leadership and Financial Management to ensure that a Strategic Plan is in Place and Resources are Available to Implement It.

2d. Creating the Strategic Plan

Strategies and Action steps were created for each goal. The outline has the following categories:

- Goals, Strategies, and Action Steps
- Responsibilities and Time Commitments
- Start Dates and End Dates for each activity
- Financial Commitment
- Status and Remarks

2d. Distribution of the Strategic Plan

The Strategic Plan was made available to the Task Force, the Chair of UMAC, and the Chair of ICOM's Strategic Planning Working Group via the UMAC webpage on 7/4/07. They also received several intermediate stages. The Plan was made available to Board Members, Members, and visitors to the website on 7/12/07. Input has been requested. A limited number of copies and supporting documents will be available at the 2007 Conference in Vienna. A presentation and discussion of the Plan will take place at the 2007 Conference.

3. Comments from the Chair

We have made great progress in our planning since forming a Working Group at our 2005 Conference in Uppsala, Sweden. This includes a survey of our members, analysis of the survey, prioritization of our goals, and a draft of a Strategic Plan. The Plan is a "working document", not a finished product, but an exercise to guide us. It is an intermediate stage.

- I think our mission and vision are farsighted and clear. We have several strong programs such as the Conference, Website, and database. We have great potential with our strengths and resources. Nevertheless, there are questions regarding the future of other programs such as the WGs and the Proceedings.
- The goals, strategies, and action steps of the Plan strongly support the mission and vision of UMAC based on the 2006 survey, input from the Task Force, Board Members, Members, and reviews of correspondence and conversations.
- Many Members have expressed the need for advocacy. As a result, I have suggested that we form a new Working Group for Advocacy. We also must question the need for our other working groups – will they contribute to our future?
- The next stage will be to revise the document by determining costs, prioritizing the goals and strategies, creating a schedule, and assigning responsibilities. We have yet to refine our content and to ask very tough questions about cost of in terms of time and funds. We have limited resources: how much we can afford to do and who will do it? I hope that in the next year that we will answer these questions. We also will review ICOM's strategic plan and revise our Plan so that we are in support of and in concert with ICOM's "Our Global Vision".
- I want to take this opportunity to give a profound thanks to the Members of the Task Force who took the time and had the interest to communicate their thoughts to me. I also want to thank my Board Members, previous Members of the WG, and other Members who responded to my requests for input. Thank You!

4. The Next Steps

The following steps are suggested:

- That all Board Members and Members review the Strategic Plan and be prepared to discuss it at our Conference in Vienna or by sending comments to me or the Chair of UMAC.
- That the Board Members begin the process prioritizing the goals, strategies, and action steps with input from the Conference participants.
- That the Board Members approve/disapprove the Mission and Vision and recommend them to the Members for final approval/disapproval.
- That the Board Members make recommendations regarding the planning process.
- That if the Board and Members desire, PT will stay on as Chair of the WG.

The network will promote and active, two-way exchange between university museum and collections research community and UMAC members, offering reciprocal advice and insight.
