Report - the Oklahoma Conference

The UMAC conference in Oklahoma attracted over 55 delegates from 14 countries. It was a lively conference with around 30 short papers of high standard.

Meetings of all the working groups were held and each revised their priorities for the forthcoming year. A new working group was formed - Publications. Full details of the new functions and aims can be found on the attachment UMAC AGM. (Attachment is written in MS Word)

In brief though, let me say that the Publications group will be responsible for new publications such as the papers from the Oklahoma conference and UMAC guidelines. It will also work with the Directories group to upgrade UMAC's website.

The Directories group, under the Chair, Cornelia Weber, has written a data-base program which will enable information about university museums and collections to be entered from many parts of the globe. UMAC's old data-base (entered by clicking on the map of the world at the top of the website) will be incorporated into the new data-base and the result will form part of the new website. The Ethics working group will be making a submission concerning conditions relating to university museums. There has also been considerable debate in ICOM-L about a new definition for the word museum. UMAC's working group has considered one originally proposed by Bernice Murphy. It reads:

Museums are permanent institutions that conserve and communicate knowledge of the natural world and the cultural inheritance of humanity through collections, records, memories, images, and sites. Museums interpret and research for present and future generations.

The debate continues and once again your input is sought.

5. Workshop for Natural History Collections

Over the last few years geology collections in university museums have come under threat. This year it is has been natural history collections. Information about a workshop to discuss the problem is attached.
